### Terms and Conditions

#### Rules & Regulations

=====

##### 1. General

- i. Whilst every reasonable precaution will be taken by DBS Bank Ltd("DBS") and People's Association (collectively the 'Organisers') to ensure the participants' safety, the Organisers, their sponsors and their appointed officials shall not be liable for any death, injury, loss, damage, cost, expense, claim suffered or incurred, howsoever arising.
- ii. Completion of the entry form confirms the participants' agreement to abide by these Rules & Regulations.
- iii. The Organisers reserve the right to cancel, delay, postpone or change the venue, date and time of the Event.
- iv. There will be no fee refund if the Event is cancelled for whatever reason.
- v. The participants consent under the Personal Data Protection Act (Cap 26 of 2012) ("Act") to the collection, use and disclosure of the participants' personal data by/to the Organisers and such other third party for the purpose of the Event and the participants confirm that they have read and agree to be bound by the terms of the DBS Privacy Policy, as may be amended, supplemented and/or substituted by DBS from time to time, a copy of which can be found on [www.dbs.com](http://www.dbs.com).
- vi. The participants consent to the Organisers contacting them for matters in relation to this Event.
- vii. The Organisers may amend any of these Rules and Regulations without prior notice or liability to any party.
- viii. The Organisers' decision on all matters shall be final. No correspondence will be entertained.

##### 2. Registration

- i. The official entry form must be completed by each prospective participant through the official on-line registration via URL at [www.posb.com.sg/runforkids](http://www.posb.com.sg/runforkids).
- ii. Registration will be accepted upon receipt of payment and all registrations will be on a first-come-first-served basis. All payments are to be charged to specified credit cards. No cheques will be accepted.
- iii. All participants will receive a confirmation slip after payment is made.
- iv. Registration for participants below 18 years of age must be made by their parents or their legal guardians.
- v. Each participant is only allowed to register under ONE (1) category.
- vi. There will be no registration on the day of the Event.

- vii. Once the registration form has been duly processed, there shall be no fee refund to participants who do not take part in the Event for whatever reason.
- viii. A participant with a valid promo code is required to enter the promo code in the online registration form in order to enjoy any discount in accordance with the discount tiers detailed in [www.posb.com.sg/runforkids](http://www.posb.com.sg/runforkids).
- ix. No refunds will be given for any promo code that is unutilized.
- x. Race categories or race entries that have been registered are non-transferrable and non-assignable by the participant.
- xi. Only the first 10,000 participants who successfully register for the Event will be entitled to participate.
- xii. The Organisers reserve the right to limit and/or decline entries.
- xiii. Selection of T-shirt size is subject to availability. No exchanges will be allowed.

### 3. Race Pack Collection

- i. All participants are required to collect their race pack which includes the Event apparel, number bib, race chip and other sponsored products (if any) (collectively the 'Race Pack') at the POSB PAssion Run for Kids 2014 – Race Expo on (to be updated in due course)
- ii. All participants are required to produce their NRIC or Passport for the collection of the Race Pack.
- iii. If the participants are unable to collect their Race Pack in person, they may authorize a representative (“Authorized Representative”) in accordance with the procedures detailed in [www.posb.com.sg/runforkids](http://www.posb.com.sg/runforkids). The participants confirm the following: (a) the Authorized Representative has consented to a DBS representative contacting him/her for the purposes of the Event;(b) undertake to comply with the provisions of the Act;(c) warrants that he/she has obtained consent under the Act from the Authorized Representative to the collection, use and disclosure of the Authorized Representative’s personal data by/to the Organizers and such other third party for the purpose of the Event; (d) confirm that he/she has read and agrees (and procures that the Authorized Representative has read and agrees) to be bound by the terms of the DBS Privacy Policy, as may be amended, supplemented and/or substituted by DBS from time to time, a copy of which can be found on [www.dbs.com](http://www.dbs.com).
- iv. The replacement fee for a lost number bib or race chip is S\$5.00 and S\$30.00 respectively.

### 4. Medical/Safety

- i. It is the responsibility of participants to have themselves medically certified fit to participate in the Event. A participant must retire from the race immediately if required to do so by any member of the official medical team.
- ii. In the event of an emergency arising from any incidents affecting the key installations in the vicinity of the Event venue, the Event will be cancelled without prior notice.

## 5. Race

- i. A participant must wear the Event apparel, number bib and race chip during the Event. Failure to do so will result in the disqualification of that participant.
- ii. Participants shall make themselves ready for their respective races ONE (1) hour before the time stated in the Event programme. The first call will be made 45 minutes before the time stated in the Event programme. The second call will be made 30 minutes before the start of the race.
- iii. Participants who do not start within 15 minutes from respective flag off will be disqualified.
- iv. Participants must run on the designated path for the entire route. Failure to do so may result in disqualification.
- v. In accordance with the International Association of Athletic Federation (IAAF), the official recognised race time is based on Gun Time for all categories, unless otherwise stated.
- vi. The recognised race time for kid's categories is based on Chip (Net) Time.
- vii. There will be no fee refunds for any participant who is disqualified for any reason.
- viii. Baggage deposit is available at the start/end point. Participants are advised not to leave any cash or valuables (including but not limited to mobile phones) at the baggage deposit counter. The Organisers shall not be responsible or liable in the event of any loss or damage.
- ix. Pets or any form of wheel-run objects of transport (including but not limited to in-line skates, prams, push chairs and shoes with rollers) are not allowed on the entire race course.
- x. Any disputes over the official race results must be made on-site in person, in a written format within FIFTEEN (15) minutes upon the release of the said results or immediately after the prize presentation, whichever is earlier. A S\$50.00 non-refundable fee will be levied per dispute investigation request. The Organisers' decision shall be final. No correspondence will be entertained.

### **Waiver Clause**

1. I fully understand and acknowledge the risks involved in my participation in the Event and I accept full responsibility and assume all such risks.
2. I hereby represent, warrant and undertake to the Organisers the following with full knowledge that they shall be relied upon by the Organisers in accepting my registration:
  - i. My personal particulars disclosed in the registration form are accurate, full and complete;
  - ii. I do not have any medical condition that would affect my safety or physical well being.
  - iii. I am medically and physically fit and competent to participate in the Event; and
  - iv. I shall dutifully and fully abide by these Rules and Regulations and any applicable laws.

3. I confirm that the representations, warranties and undertakings herein are true and accurate.
4. I (including my heirs, successors and assigns) undertake not to make any claims or lodge any complaints whatsoever against the Organisers, Sponsors or officials of the Event for any injury, death or loss/damage to property sustained during the Event/disputes over any matter in relation to the Event.
5. I (including my heirs, successors and assigns) agree to hold the Organisers, Sponsors, appointed officials/suppliers (each an 'Indemnified Party') harmless and keep each Indemnified Party fully and effectively indemnified from and against any and all losses, costs (including legal costs on a full indemnity basis), claims, damage and expenses whatsoever which any of them may incur (directly or indirectly) as a result of my breach of any of these Rules and Regulations.
6. These Rules and Regulations shall be governed under Singapore laws and I agree to submit to the exclusive jurisdiction of the Singapore courts.
7. I am agreeable to the Organiser's or its appointed vendor to sms or email me on any service related updates with regards to this event purpose only.
