

Terms and Conditions Governing the Kaohsiung Mastercard Free Ride Fridays Promotion (“Promotion”)

Participation in the exclusive promotion (“Promotion”) constitutes acceptance of these Terms and Conditions.

1. The promotion is valid from **4 January 2019** to **28 February 2019**, both dates inclusive (“**Promotion Period**”).
2. Promotion is open to cardmembers/users of Singapore-issued POSB/DBS Mastercard Cards (each a “**Participant**” and collectively, the “**Participants**”).
3. To qualify for this promotion, customers (“**Eligible Cardmembers**”) must use their Singapore-issued POSB/DBS Mastercard Card for transit ride(s) on Kaohsiung Rapid Transit System (MRT), and trigger at least two successful taps (both entry and exit), on any Friday during the promotion period.
4. Participants must have an active Singapore-issued POSB/DBS Mastercard Card (“**Card**”) with the requisite funds/credit limit to cover their transit costs during the promotion period.
5. The free transit ride(s) on Fridays will be charged to the Card as per normal and credited at the end of the campaign as cashback.
6. The cashback is subject to a cap of S\$30 per customer per campaign period regardless of the number of POSB/DBS Mastercard Cards used by the customer for transit rides on Kaohsiung MRT. Cashback is calculated based on the Singapore dollar denominated transaction amount every Friday during the promotion period. Cashback will be calculated based on each Friday’s transaction date, starting from 4 January 2019 to the end of the promotion period (28 February 2019).
7. Cashback earned for the transit transactions during the promotion period will be credited within two calendar months after the promotion period (i.e. by end of April 2019) to the Card. Where a customer has used more than one Card for this Promotion, the Cashback will be credited back to the Card in priority of the highest transit spend on Fridays over the campaign period.
8. The Card must be in good standing or not blocked for use and conducted in a proper and satisfactory manner as determined by DBS in its sole discretion at the time of crediting the Cashback. In the event that the relevant account is delinquent, voluntarily or involuntarily closed or terminated or blocked for use for any reason whatsoever before the Cashback is credited into the said account, DBS reserves the right not to credit the Cashback.
9. DBS reserves the right to claw-back the Cashback amount without prior notice, at its discretion charging the full retail value of the Cashback amount, if it subsequently determines that the customer is in fact not eligible to receive the Cashback, including where the Cashback was awarded due to an error or the transaction is not a transit ride spending.
10. DBS may vary these Terms and Conditions or suspend or terminate the Promotion without any prior notice or liability to any party.

11. Participants consent under the Personal Data Protection Act (Cap 26 of 2012) to the collection, use and disclosure of the Participants' personal data by/to the DBS' agent or vendors and such other third party for the purpose of the Promotion and Participants confirm that they agree to be bound by the terms of the DBS Privacy Policy, a copy of which can be found on www.dbs.com/privacy.

DBS assumes no responsibility for any losses or damages or expenses arising in connection with this Promotion, howsoever arising, including without limitation, from any late or non-notification, any error in computing, technical hardware or software breakdown, malfunctions or defects, failed, delayed or incorrect transactions, or lost or unavailable network connections, or any notice that is lost or misdirected, which may affect the Customers' eligibility in the Promotion.
13. These terms and conditions shall be read in conjunction with the DBS Cards General Promotions Terms & Conditions. In the event of any inconsistency, these terms and conditions shall prevail insofar as they apply to the Promotion.
