

Terms and Conditions Governing the NETS Tap & SimplyGo Transit Rebate Promotion (1st Feb 2020 – 31st Mar 2020) (“Promotion”)


Participation in the exclusive promotion (“Promotion”) constitutes acceptance of these Terms and Conditions.

1. The promotion is valid from **1st February 2020** to **31st March 2020**, both dates inclusive (“**Promotion Period**”).
2. The Promotion is open to the first 18,000 contactless ATM cardholders who spent S\$30 with NETS Tap for transit (public bus & MRT) per month (each a “**Participant**” and collectively, the “**Participants**”).
3. The Promotion allows Participants to earn S\$5 rebate when they spend S\$30 per month on transit in Singapore using NETS Tap during the Qualifying Period (“**Rebate/ Rebates**”).
4. Participants are eligible to only one S\$5 rebate per card per month.
5. The following POSB/DBS NETS Contactless ATM cards enabled for NETS Tap are eligible. POSB/DBS NETS Contactless ATM card displays the following symbol on the front of the card.

5. Participants are advised to add/ link their ATM card to their TransitLink SimplyGo account on the TransitLink SimplyGo app/ website to keep track of their travel spend using the NETS Contactless ATM cards. To sign up for a TransitLink SimplyGo account, visit the TL SimplyGo app/ website.
6. Tap in and out using the same card and take out your card from your wallet/ bag to prevent card clash and avoid multiple charges.
7. Participants must have sufficient funds in their bank account to cover their transit costs during the Qualifying Period.
8. Rebates earned during the promotion period will be credited within 2 calendar months to your POSB/DBS Current or Savings Account ('CASA Account') that is linked to the POSB/DBS NETS Contactless ATM card e.g. S\$5 rebate to be credited by end April for the trips taken in February.
9. The POSB/DBS NETS Contactless ATM Cards that are linked for ABT must be at good standing or not blocked for use and conducted in a proper and satisfactory manner as determined by DBS in its sole discretion at the time of crediting the Cashback. In the event that the relevant account is delinquent, voluntarily or involuntarily closed or terminated or blocked for use for any reason whatsoever before the Cashback is credited into the said account, DBS reserves the right not to credit the Cashback.
10. DBS reserves the right to claw-back the Cashback amount without prior notice, at its discretion charging the full retail value of the Cashback amount, if it subsequently determines that the customer is in fact not eligible to receive the Cashback, including where the Cashback was awarded due to an error or the transaction is not a transit ride spending.
11. DBS may vary these Terms and Conditions or suspend or terminate the Promotion without any prior notice or liability to any party.

Participants consent under the Personal Data Protection Act (Cap 26 of 2012) to the collection, use and disclosure of the Participants' personal data by/to the DBS' agent or vendors and such other third party for the purpose of the Promotion and Participants confirm that they agree to be bound by the terms of the DBS Privacy Policy, a copy of which can be found on www.dbs.com/privacy.

DBS assumes no responsibility for any losses or damages or expenses arising in connection with this Promotion, howsoever arising, including without limitation, from any late or non-notification, any error in computing, technical hardware or software breakdown, malfunctions or defects, failed, delayed or incorrect transactions, or lost or unavailable network connections, or any notice that is lost or misdirected, which may affect the Customers' eligibility in the Promotion.
