

Terms and Conditions (“Terms and Conditions”) for “Cashline receive up to S\$110 Cashback Promotion” (“Promotion”)

- Promotion is available from 1 February 2023 to 31 July 2023 (“Promotion Period”).
- Successful applicants (“applicants”) will receive the following cashback amount (“Cashback”), if the following conditions are satisfied within the Promotion Period:

Tier 1: S\$50 Cashback (“Tier 1 Cashback”)

- Successfully applied for a Cashline account (“Cashline”)

Tier 2: Up to additional S\$60 Cashback (“Tier 2 Cashback”)

- Successfully applied for Cashline and completed at least 3 transactions each month for 3 months from Cashline approval month

Conditions:

- Application must be made via self-apply online application platform.
- Must not hold an existing Cashline.
- Must not have any cancelled Cashline within the last 6 months from date of application.
