

POSB Everyday Card Terms and Conditions

1. Promotion is valid till 30 September 2018. 5% discount when charged to any DBS/POSB Credit or Debit Card (with the exception of DBS Esso MasterCard Cards) plus 10% discount with SPC&U Card. Aforementioned discounts only applicable for petrol purchases. POSB Everyday Cardmembers enjoy 6% cash rebates on the final charge amount (after any other applicable discounts).

2. Promotion is valid from 1 June to 30 September 2018. Eligible cardmembers will receive 10% cash rebates on online food delivery and 5% cash rebates on spend at restaurants, bars, entertainment establishments, cafes, fast food outlets and caterers, subject to a minimum spend of S\$800 per calendar month. Cash rebates earned under this promotion is capped at S\$50 per calendar month. View full terms and conditions [here](#).

3. Promotion is valid from 2 May to 31 July 2018. 5% cash rebates on Overseas Spend is subject to a minimum spend of S\$1,000 on overseas transactions per calendar month and is only applicable to card-present transactions. 4. Cash rebates will be awarded on a maximum spend of S\$1,000 (equivalent to Daily\$50) at Sheng Siong per calendar month.

5. 1% cash rebates on your POSB Everyday Card for SP Group and StarHub will be credited by the end of the following calendar month on the month the transaction is made. No cash rebates will be awarded beyond the maximum spend of S\$100 per month. For SP Group, recurring charges are applicable only to accounts under the name of the main or supplementary cardholder.

6. Cash Rebates will not be awarded on:

- payments to educational institutions;
- payment to government institutions and services (court cases, fines, bail and bonds, tax payment, postal services, parking lots and garages, intra-government purchases and any other government services not classified here);
- payment to insurance companies (sales, underwriting, and premiums);
- payment to non-profit organisations;
- Betting (including lottery tickets, casino gaming chips, off-track betting, and wagers at race tracks) through any channel;
- any top-ups or payment of funds to any payment service providers, prepaid cards and any prepaid accounts;
- bill payments and all transactions via AXS or SAM;
- instalment payment plan purchases, preferred payment plans, balance transfer, fund transfer, cash advances, annual fees, interest, late payment charges, all fees charged by DBS, miscellaneous charges imposed by DBS (unless otherwise stated in writing by DBS); any other transaction effected via any medium or channel, electronic or otherwise, which transaction, medium or channel DBS Bank may in its sole and absolute discretion choose to disallow
