

## **DBS/POSB Credit Cards or Cashline Pweb Credit Limit Review ("Promotion") Terms and Conditions**

These Terms and Conditions govern the Promotion. Participation in the Promotion constitutes acceptance of these Terms and Conditions:

1. The S\$30 Cash Rebate ("**Gift**") is limited to the first 3000 DBS/POSB Credit Card and Cashline Customers ("**Customers**") whose Credit Card or Cashline Credit Limit Review application is submitted via DBS website, DBS iBanking or DBS Digibank App and whose credit limit increase is approved by 31 August 2019 ("**Qualified Customers**").

3. The Gift will be credited into your DBS Credit Card/Cashline account with the latest transaction activity (at DBS' discretion), by 30 November 2019.
