

TERMS AND CONDITIONS GOVERNING DBS X CIRCLES.LIFE PROMOTION (“PROMOTION”)

General Terms and Conditions

1. This Promotion is organised by DBS Bank Ltd (“DBS”) and Liberty Wireless Pte. Ltd (“Circles.Life”, hereinafter referred to as “the Company”), collectively referred to as “the Organisers”
2. By entering the Promotion, you represent that you have read, understood and agreed to be legally bound by these terms and conditions.
3. By registering or subscribing to Circles.Life services, you issue consent for the Organisers to collect, use and disclose all your personal data, including but not limited to your photographs, contact information and names submitted in the Promotion for completion of your application and providing marketing material as the Organisers deem fit in accordance with the Personal Data Protection Act 2012. Offer and Redemption

5. This Promotion is limited to the first 10,000 redemptions only.
6. This Promotion is open to all DBS/POSB Credit or Debit principal and supplementary cardmembers (“Cardmembers”).
7. To qualify for the Promotion, Cardmembers must:
 - a. Enter the promo code **DBSNDP** upon checkout at Circles.Life
 - b. Use a DBS/POSB Credit or Debit Card (“Card”) for the checkout payment
 - c. Complete the mobile-plan checkout on Circles.Life website successfully
8. All qualified customers should not turn on the "Unlimited Data" option under "Add-on Options" in the Circles.Life app. The 9 months free unlimited data will be applied automatically.
9. \$18/month offer is only valid for users who port-in their existing Postpaid number from another service provider other than Circles.Life, and this offer will expire 12 months from the date of sign-up with the price reverting to \$28/month thereafter.
10. Customers who select a new number will not be entitled to the \$18/month offer and will instead be on the \$28/month plan.
11. All qualified Cardmembers will enjoy free unlimited data add-on for a period of 9 months (U.P. \$20/month) from the date of subscription (“Promotional Benefits”).
