

Terms and Conditions for DBS/POSB Mastercard® Cards and UEFA Champions League Promotion (“Promotion”)

1. The Promotion is from 1 November 2017 to 31 January 2018 (“**Promotion Period**”).
2. To participate in this Promotion, you must hold either one of the following DBS/POSB Mastercard Debit or Principal/Supplementary Credit Cards (“**Eligible Cardmember**”):

During the Promotion Period, each Eligible Cardmember will earn one (1) entry for every ten (10) retail transactions (of any amount) using Mastercard Paypass® at contactless payment terminals (point-of-sale terminals) of merchants whether located within Singapore or outside Singapore; and one (1) entry for every S\$10 charged on fares for public buses and MRT/LRT trains operated by the Land Transport Authority of Singapore (“**LTA**”) via Account Based Ticketing (ABT).
4. The Promotion allows fifteen (15) Qualified Cardmembers from all participating issuers, to receive the following travel package prize (“**Prize**”) to the UEFA Champions League Finals 2018 football match in Kyiv, Ukraine:
 - a) return economy class air tickets for two (2) from Singapore to Kyiv, Ukraine on an airline selected by Mastercard;
 - b) 4 days/3 nights (24 to 27 May 2018) hotel accommodation in Kyiv, Ukraine for two (2) persons on a twin sharing basis at a hotel selected by Mastercard;
 - c) Airport transfers in Kyiv, Ukraine;
 - d) A full-day sightseeing tour of Kyiv, Ukraine covering renowned landmarks in Kyiv, Ukraine;
 - e) a hospitality dinner for two (2) persons in Kyiv, Ukraine at a venue selected by Mastercard; and
 - f) two (2) tickets to watch the UEFA Champions League Finals football match in Kyiv, Ukraine. The seating for the tickets will be determined by Mastercard.
5. Qualified Cardmembers whose Mastercard Card accounts are cancelled, terminated or suspended for any reason during the Campaign Period are not eligible for the Campaign

Qualifying spend are based on local and foreign retail contactless sales via Mastercard Paypass® and local transactions via Account Based Ticketing (ABT) but it excludes posted recurring bill payment, posted 0% interest-free instalment plan, posted My Preferred Payment instalment plan, interest, finance charges, cash withdrawal, balance transfer, smart cash, AXS payments, SAM bill payments, bill payments via internet banking and all fees charged by DBS. Supplementary card spend is considered as stand-alone for accumulation of entries.
7. The Qualifying Card must be at good standing or not blocked for use and conducted in a proper and satisfying manner as determined by DBS in its sole discretion at the time of selection and notifying winners. In the event that the relevant Card Account is delinquent, voluntarily or involuntarily closed or terminated or suspended for any reason whatsoever before the redemption letter is mailed to Participant, DBS reserves the right to not award the Prize.
8. The Prize redemption letter will be mailed to the Eligible Cardmembers' registered address with DBS' records no later than 31 March 2018.
9. The prize is non-exchangeable, non-transferrable and non-replaceable, courtesy of Mastercard, official sponsor of the UEFA Champions league.

Subject to the DBS Debit Card Agreement, the maximum liability for unauthorised transactions not due to your negligence is S\$100. Please allow up to 14 days to process refunds.
