



## Terms and Conditions Governing POSB Smart Buddy New 5<sup>th</sup> Generation Watch Launch Promotion (Spend2Upgrade) (“Promotion”)

Participation in the Promotion constitutes acceptance of these Terms and Conditions as well as the [Terms and Conditions Governing POSB Smart Buddy Programme](#).

1. The Promotion is valid from 08 May 2023 to 31 July 2023 (“**Promotion Period**”).
2. To qualify for this Promotion, customers must fulfil the criteria as set out below within the Promotion Period:
  - Existing Smart Buddy user with an activated POSB Smart Buddy card/payment chip on the POSB Smart Buddy App.
  - Successfully perform a minimum of 35 payment transactions on the POSB Smart Buddy card/payment chip.
3. Customers who fulfill the criteria (**each a “Participant”, collectively the “Participants”**) in Clause 2 will be entitled to receive a free Smart Buddy 5<sup>th</sup> Generation watch (“**Gift**”).
4. The Gift redemption code will be shared with Participants via push notification on the POSB Smart Buddy App to the Participant’s linked Smart Buddy parent profile, upon successful fulfilment of criteria in Clause 2.
5. Participants can then redeem the Gift by entering the Gift redemption code before checking out on [eShoppenow](#) site.
6. The Gift is only limited to the first 10,000 Participants within the Promotion Period, while stock last. Each Qualified Participant is strictly entitled to only 1 Gift for this Promotion.
7. The Gift is strictly non-redeemable for cash, non-transferable, non-assignable, non-exchangeable and non-replaceable.
