

Terms and Conditions Governing the DBS Pay with Apple Pay May Promotion

The Promotion

1. The DBS Pay with Apple Pay May Promotion ("**Promotion**") is organised by DBS Bank Ltd. ("**DBS**") and is valid from 1 May 2017 to 31 May 2017, or while stocks last, whichever is earlier ("**Promotion Period**"). Promotion is valid for the first 120,000 qualified transactions ("**Qualifying Transaction**") at Starbucks Coffee Singapore Pte Ltd ("**Starbucks**"), for the first 20,000 qualified transactions at Toast Box Pte Ltd ("**Toast Box**") and for the first 30,000 qualified transactions at UBER Pte Ltd ("**UBER**").
2. Participation in the Promotion constitutes acceptance of these Terms and Conditions.

Eligibility and Mechanics

3. To qualify for the Promotion, customers must be an existing DBS/POSB Consumer Visa/Mastercard Credit or Debit Card ("**DBS/POSB Card**") cardmember ("**Cardmember**"), whose Card Account(s) are valid (individually a "**Card Account**" and collectively "**Card Accounts**") and in good standing with DBS.
4. The Cardmember must also fulfill the following mechanics to qualify for the Promotion as a qualified Cardmember (individually a "**Qualified Cardmember**" and collectively "**Qualified Cardmembers**"):
 - 4a. Successfully enroll their DBS/POSB Card on Apple Pay before or during the Promotion Period; and
 - 4b. Successfully charge S\$0.90 in a single receipt for a retail contactless transaction at Starbucks, Toast Box and/or UBER with any of their valid DBS/POSB Card(s) via Apple Pay during the Promotion Period.
5. Supplementary Cardmembers will also qualify for this Promotion provided they have met the qualifying conditions explained in Clause 4 above.
6. "**Qualified Transaction**" is determined based on posted local retail contactless transaction (by both principal and supplementary cards) where Apple Pay is accepted, but excludes 0% interest-free instalment plan, recurring bill payment interest, bill payment, finance charges, cash withdrawals, balance transfer, smart cash and all fees charged by DBS.
7. DBS shall not be responsible for any failure or delay in posting of sales transactions which may result in a Cardmember being omitted from the Promotion.
8. Each Qualified Cardmember will be able to purchase a S\$0.90 deal ("**Deal**") when they make a Qualifying Transaction at Starbucks, Toast Box and/or UBER. Please visit the links below for the full list of Starbucks and Toast Box outlets, and to download the UBER Application:

9. Promotion is valid from 1 May 2017 to 14 May 2017.
10. Promotion is only applicable for any Tall-sized Starbucks drinks at any Starbucks outlets.
11. Promotion is not valid with other promotional offers or discounts.

12. Any change in the size of the drinks or additional condiments are to be paid for by customers.
13. Each Qualified Cardmember is entitled to one redemption per transaction for this promotion during the Promotion Period.

S\$0.90 Toast Box Terms and Conditions

14. Promotion is only applicable for Traditional Toast Sets which include Traditional Toast, 2 half-boiled eggs and medium size Kopi/Teh at all Toast Box Singapore outlets, excluding Marina Bay Sands, Resort World Sentosa and Tea Loft at Suntec City.
15. Each Qualified Cardmember is entitled to one redemption per transaction for this promotion during the Promotion Period.

S\$0.90 UBER Terms and Conditions

16. Each Qualified Cardmember is entitled to a S\$0.90 UBER ride for the first transaction per day per Qualified Cardmember, capped at a maximum fare of S\$10.
 - i. Scenario 1:
For an UBER fare of S\$12, Qualified Cardmember will receive a maximum amount of S\$9.10 as cashback to his Card Account.
 - ii. Scenario 2:
For an UBER fare of S\$8, Qualified Cardmember will receive a maximum amount of S\$7.10 as cashback to his Card Account.
17. Discount will be credited as a form of Cashback into the Qualified Cardmember's Card Account within two calendar month after the end of promotion, i.e. 31 July 2017.
18. Promotion is only applicable for all types of UBER rides taken in Singapore.
19. A base fare of minimum S\$3.00 will be charged for every payment on Apple Pay, which will vary according to the type of UBER ride selected.
20. Promotion is not applicable for UBEREATS.

General

21. DBS will have the final decision on all matters regarding the Promotion.
22. DBS may change these terms or suspend/terminate the Promotion without giving notice.
23. Notwithstanding anything herein, DBS has the absolute discretion to determine the eligibility of any person to participate in the Promotion.
24. If DBS subsequently determines that a person is in fact not eligible to receive the Gift or to participate in the Promotion, for any reason whatsoever, DBS may at its discretion charge the full retail value of the Gift to the Cardmember without prior notice. Each participant of the Promotion authorizes and consents to DBS charging the full retail value of the Gift to any of his/her/their DBS/POSB Credit & Debit Card account(s).

25. These terms and conditions shall be read in conjunction with the DBS Cards General Promotions Terms & Conditions. In the event of any inconsistency, these terms and conditions shall prevail insofar as they apply to the Promotion.
