



**Terms and Conditions Governing POSB Child Development Account (“CDA”) Parent Starter Kit Promotion (“Promotion”)**

1. The promotion period shall last from 1 July 2020 till 30 April 2022 (“**Promotion Period**”) *\*Extended*
2. CDA Customers (“**Eligible Customers**”) who open a POSB Child Development Account, and activate the Reserved Account(s), being either the Personal My Account and/or the Joint-Alternate My Account during the Promotion Period will be eligible to receive a POSB Parent Starter Kit (“**Promotion Gift**”)

3. The Reserved Account(s) must be activated within 90 days from the date of account opening. The Reserved Account(s) activated after 90 days from the date of account opening may be automatically closed without any prior notice to you notwithstanding successful activation.
4. Promotion Gift is only limited to the **first 3,000 redemption** on a first-come-first-serve basis, while stocks last.
5. Redemption EDM will be sent to the customer's email as registered in our bank records, within one (1) month from the date that customer fulfills the conditions as stated.
